# Message from the President

#### Dear Friends.

2022 was quite a challenge but not necessarily in a bad way. Longtime Executive Director, Ted Vander Roest, retired at the end of April. As such, the Board retained a search firm with the goal of hiring a new Executive Director. The search was long and intense, but the Search Committee wanted to ensure we were putting the right person at the helm of the Foundation. Someone who would continue to build upon the existing foundation while incorporating new and exciting changes that would propel us into the future. Susan Carey met these criteria and the Board hired her as the new Executive Director.

As pandemic-challenges were starting to wane for some people, they persisted for others. Consequently, we held both committee meetings as well as full Board meetings in a hybrid fashion. We remained resilient and continued to do the committee work to ensure that we, along with our partners, were able to support the community in the same ways that we had in the past. We welcomed Lori Boegershausen as the new grants manager and Teresa Brumfield was promoted to scholarship manager. New and existing scholarships were awarded in the amount of just over \$599,000, discretionary grants were awarded just north of \$840,000, and Aaron Clark and Pam Meerman were brought on as new Board members. The DEI Committee, which was new in 2022, worked with Clark State College to host a three-part training series dedicated to embracing the challenges and success of DEI in the workplace. A new initiative committee was put in place since our SpringForward commitment had been fulfilled. We ended the year with \$12.8 million in total gifts and over \$109 million in assets. Last but not least, we updated our motto to reflect our renewed commitment to serving everyone in our community:

#### "For good. For ever. For all."

As we collectively emerge from a devastating pandemic, I would like to thank you all for your continued generosity and commitment to the Springfield Foundation. Together we are strengthening and improving our community for all.

# Creating Lasting Impact

In 2022, the following donors partnered with the Springfield Foundation to create permanent endowment funds. These new funds will have an impact forever and each builds upon our shared lives and passions.

#### James H. Baker Fund

Created by the estate of James H. Baker, this fund will support Covenant Presbyterian Church, The Clark County Historical Society, The Ray C. Bliss Institute of Applied Politics at Akron University, the endowment fund of the Hun School at Princeton, Ferncliff Cemetery and the Clark County Master Gardeners.

## **Helen J. Brumfield Designated Fund**

This fund benefits the United Methodist Churches of Springfield, Clark State School of Nursing, local organizations providing hospice care, the Clark County Library, the Southern Village Library Branch, and the Alpha Eta Chapter of the Delta Kappa Gamma Society International.

#### Helen J. Brumfield Clark-Shawnee Scholarship Fund

This scholarship assists graduates from Clark-Shawnee High School to further their studies at an accredited college or university.

#### The Morris Family Endowment Fund

An unrestricted endowment fund to support local nonprofit organizations through the Foundation's grantmaking process.

#### The James and Patricia Bean Fund

This deferred fund will support the missionary work of the Hillard Church of Christ.

#### The Carleton F. and **Ruth T. Davidson Trust**

The fund shall be used for unrestricted support of the charitable or educational purposes of The Carleton F. and Ruth T. Davidson Trust and its affiliated agencies.



## The Esther I. Manuel **Youth Arts Ambassador Fund**

This fund supports the Youth Arts Ambassador program (arts education) of the Springfield Arts Council.

#### The Karen S. Rose Fund

This deferred fund will support Cornerstone Baptist Temple, Dayton Children's Hospital, St. Jude's Children's Research Hospital, Clinton County Humane Society, Helping Animals Lost and Orphaned (HALO), Freedom Service Dogs of American, and K9s for Warriors.

#### Springfield Symphony Orchestra **Association Guest Artist Fund**

The Fund shall be used for unrestricted support of the Springfield Symphony Orchestra Association and its affiliated agencies.

#### Nancy E. Thibeault and Rodney S. Jones Scholarship

This deferred scholarship will support a graduating senior from Greenon High School, pursuing further education in science, technology, engineering, mathematics, medicine, or education.

#### **Ted and Jodi Vander Roest Donor Advised Fund**

This fund was established in honor of Ted Vander Roest's retirement from the Springfield Foundation to support non-profit organizations of his and Jodi's choosing.









# Wittenberg University's Summer Civic Internship Transforms Young Adults

The Susan Hirt Hagen Center for Civic & Urban Engagement at Wittenberg **University** hosted its 15th annual Summer

Civic Internship program in 2022 with support from the Springfield Foundation. The funds from the Springfield Foundation subsidize the wages or housing of student interns, making the program more affordable for nonprofit partners who may not otherwise be able to afford a full-time staff member for the summer.

The program hosts 15-20 Wittenberg students each year and begins with a 3-day orientation to Springfield. In 2022, interns visited the Heritage Center, toured downtown with Kevin Rose, completed service projects at Jefferson Street Oasis, and toured Rocking Horse Community Health Center. This allows them to meet community leaders and see firsthand how people are contributing to positive change in the Springfield community. After orientation, students work full-time (37 hours/week) with local organizations for example, the City of Springfield, Project

Jericho, National Trail Parks and Recreation, Springfield Promise Neighborhood, and others. Weekly dinners engage students and community leaders in conversation on topics ranging from professional development to social entrepreneurship to policy and governance. At the end of the program, students present their reflections about the experience to a public audience.

The outcomes of the program are beneficial for both students and community partner organizations. Nonprofit partners reported overwhelmingly positive feedback such as "[Our intern] has extended our capabilities as an organization and invested into the

wellbeing of our youth participants" and [Our intern] is actively contributing to health equity in Springfield." These experiences are equally beneficial for students who reported an increase in motivation to serve their communities and confidence in their ability to contribute to positive social change. Without funding from the Springfield Foundation, these transformational experiences would not be possible.

The Summer Civic Internship Program runs every summer from the last week in May through the end of July and is open to nonprofit, government, and educational organizations.

# Children's Defense Fund Freedom School Supports Our Children

#### Covenant United Methodist Church's Children's Defense Fund Freedom School

is offered at no cost to families, and this would not be possible without support from people and organizations like the Springfield Foundation. The Springfield Foundation's support has enabled the Covenant Freedom School to purchase books, provide meals and offer field trips for the scholars.

The Covenant Children's Defense Fund Freedom School has just completed the 6th year of bringing this program to the children and families of Springfield and Clark County. They enroll 40 scholars for the 6 week summer program. The first step in establishing a CDF Freedom School in Springfield was to partner with colleges and community organizations. The first staff came from the Hagen Center of Wittenberg University. They reached out to several community organizations for volunteers and financial assistance. The Springfield Foundation was one of the first to support the Covenant CDF Freedom School.

The goal of Covenant Freedom School is to assure that our participants (scholars) and their families are able to grow academically, intellectually and emotionally. Scholars work on reading and reading comprehension so that by the end of the 6 weeks of Covenant Freedom School, they show no summer learning loss and exhibit an increase in their reading and reading comprehension skills.

Parents/Caregivers are able to receive information about the work their children



are doing and also learn about community resources such as mental health options and financial planning, through the required weekly Parent Engagement.

For each year of data collected, the scholars of the Covenant Freedom School have shown an increase in reading skills and a reading comprehension, and show no summer learning loss.

# Glen Helen's Outdoor Education Center Inspires Young Students

The Springfield Foundation's grant has enabled **Glen Helen** to start another great season of life-shaping residential environmental learning at the Outdoor Education Center. The Outdoor Education Center is fully staffed, with a core team of five, plus nine naturalist interns. This team will continue the Glen's legacy to teach, guide, and inspire children.

This support also made it possible to complete an ambitious suite of improvements to the Outdoor Education facilities, ensuring that the buildings are code compliant and ready to host schoolchildren. Efforts included an all-new yurt classroom, kitchen improvements, and new furniture in the Lodge. The newly constructed boardwalk allows students and families to see the beaver dam and lodge up close, and, if they're lucky, to see the animals themselves.

Their mission is to relieve some of the everyday stressors so the family can focus on the care and advocacy for their child.

These pictures are the Plantz family from Springfield. They stayed at the Ronald McDonald House while their newborn son was at Dayton Children's for a variety of medical reasons. One of the highlights of their stay was the Halloween party put on by staff and volunteers. They also participated in weekly Pet Therapy and Arts & Crafts night. The family was a joy to have in the house and at the end of their stay their son remained in the NICU, but the family had to return home for work and family obligations. Since they are no longer guests in the House, they make regular use of the Ronald McDonald Family Room at Dayton Children's Hospital. The medical journey continues to this day for their son, and they know that they can return to the Ronald McDonald House whenever they need to.

# Autumn Trails Stable's Strengthens Children with Disabilities

#### Unlike many organizations, Autumn Trails Stable's services rely on the horses.

They are unique and they are what make it work. Autumn Trails Stable's participants only pay about 30% of what it actually costs to provide the offered services. Horses are very expensive. Horses doing what are asked of them at Autumn Trails Stable need more specialized care than other horses would. It can be a high stress job for them. Without the help of The Springfield Foundation and other organizations like them, it would be very hard to continue to offer these services in an affordable manner. Every time a services is provided to an individual, the organization must raise a minimum of \$150.

In supporting Autumn Trails Stable, the Springfield Foundation gives individuals with disabilities, especially children, the chance to participate in something that is their very own. Many of their participants cannot participate in regular extracurricular activities so adaptive riding is special for them. They work on strengthening their physical abilities, but also their cognitive, social, and emotional abilities - all through the use of a horse. While many activities can be a struggle, doing those same activities on the top of a horse seems to lessen the burden. Through specialized lesson plans created by certified instructors, participants meet goals that many never thought were possible. Autumn

Trails Stabe strives to make the impossible become possible and without partners like The Springfield Foundation they could not achieve that.




## James Baker

From an early age, he displayed a passion for logistics and operations, gaining expertise while working with Ringling Brother, Barnum & Bailey Circus. Throughout his career, Mr. Baker held significant roles in the political and event management arenas.


He served as the Executive Assistant to Ray Bliss, Chairman of the Ohio State Republican Party and the Republican National Committee. Mr. Baker contributed to the Republican National Conventions as the Director of Operations for multiple years and as the Director of Logistics and Operations for subsequent conventions. He also played a vital role in the Presidential Inaugural Committee, overseeing the construction of parade routes and reviewing stands.



Mr. Baker's dedication extended beyond politics. He served as the Director of Operations and Scheduling for the American Freedom Train during the Bicentennial celebration of the United States. As President of JHB Enterprises, he provided government relations services to Fortune 500 Companies and offered event planning and logistical management services to various clients.

Outside of his professional endeavors, Mr. Baker was an active member of Covenant Presbyterian Church and The Association of Ohio Commodores, Inc. He also served on the Clark County Historical Society Board of Directors. Mr. Baker cherished his time with family, managed the family farm, and enjoyed his annual trip to Sarasota, FL. His passion for national projects and events matched his dedication to personal endeavors.



## Investment overview

A majority of the Springfield Foundation's endowment funds is invested in a "Balanced Pool" portfolio, which is structured for long-term total return. To provide diversification and to reduce overall risk, the investments are divided into carefully defined asset classes. Assets are invested by professional money managers hired by the Foundation through a competitive process. The investment performance of each money manager is monitored by an independent investment consultant retained by the Foundation and overseen by the Foundation's Investment Committee. A list of our current investment managers is available at the Springfield Foundation office.







# 2022 Springfield Foundation DEI Update

The DEI Committee continued to support Dr. Raphael Allen in his role as Director of Community Outreach. The committee encouraged him to serve as the convener of information gathered from local conversations which resulted in a community narrative that can be used by groups looking to better serve the community.

The committee held a short DEI training session at the beginning of a Board meeting to keep the members engaged in conversations surrounding diversity, equity and inclusion, and they plan to do that at several Board meetings in the future. On July 20th, Board members, staff members, and non-profit leaders had the opportunity to engage with Yolanda Stephens, Daytonarea Performance Coach and Diversity Trainer, during an afternoon session with a focus on implementing DEI practices.

Through the grantmaking process, it was determined that there isn't much Board member diversity within grant seeking organizations. Dr. Allen created documents that will be part of the grant application packet encouraging prospective grantees to increase Board diversity and offering suggestions for how to accomplish that.

The DEI committee reviewed the Springfield Foundation's DEI statement and determined that it is still relevant to our work. A proposal to the Board to keep the current document was approved.

Parameters for a DEI award to be given to an organization within the community were discussed. Conversation will continue with the goal of presenting the award at the 75th anniversary celebration in 2023.
